The Board of Directors of your Company at its meeting held on 11.04.2018 has appointed me as a Scrutinizer for conducting the Postal Ballot voting process including voting by electronic means.

The management of the Company is responsible to ensure compliance with the requirements of the relevant provisions of:

- (a) The Companies Act, 2013 and the Rules made thereunder; and
- (b) The Listing Agreement(s) with the Stock Exchange, relating to Postal Ballot voting including voting by electronic means.

- iii All physical postal ballots received till the time fixed for closing of the Postal.

 Ballot on Sunday, 03rd Jun, 2018 at 5.00 P.M were diligently scrutinized and reconciled with the records maintained by the Company through Venture Capital and Corporate Investments Private Limited , the Registrar and Share Transfer Agents of the Company and the authorizations lodged with the Company.
