1) The above unaudited financial results for the Quarter/ Nine Months ended 31st December 2025 have been reviewed and recommended by the Audit Committee and approved by the Board of Directors at their meetings held on 03rd February 2026. The statutory auditors have carried out review of these Financial Results and have issued an unmodified report on these results.

2) The Group has opted to publish the Unaudited Consolidated Financial Results for the Quarter ended 31st December 2025, Investor can view the unaudited Standalone Financial Results on the Company's website: www.adroitinfotech.com.

3) Segment Reporting- Sole business segment

Based on the "Management Approach" as defined in Ind AS 108 - Operating Segments, the Company is primarily engaged in the business of SAP Support Services which the management recognizes as the sole business segment. Hence, disclosure of segment-wise information is not required and accordingly, not provided

4) The Company Issued the Rights Issues of up to 3,25,01,058 Partly Paid-up Equity Shares of face value of Rs. 10 each ("Equity Shares") of Adroit Infotech Limited ("AIL" or the "Company" or the "Issuer") for cash at a price of Rs.15 per equity share (including premium of Rs. 5 per equity share) ("Issue price") to the eligible equity shareholders on rights basis in the ratio of 3 (three) equity Shares for every 2 (two) equity shares held by the eligible equity shareholders and for the purpose of Company's Diluted Earning per share the said shares are considered on prorate basis. On the above Rights Issue, the Company has made application, first call and 2nd and final call. Out of this, the Company is yet to receive the balance amount as under:

-on 18,99,942 shares first call and final call money @ Rs.11.25 per share (including premium of 3.75). -on 11,91,280 shares the final call money @ Rs. Rs.7.50/- per share (including premium of Rs.2.50).

The company will make a call on the above after the Board of Directors decides about the date.
