

Subject: <u>Administrative warning letter – Non-Compliance with SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018.</u>

- SEBI has observed violation of Regulation 169(2) of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("ICDR Regulations") by Adroit Infotech Ltd ("the company/ AIL") as per the details given below:
  - 1.1.AIL had allotted a total 45,00,000 convertible warrants on November 16, 2022 of Adroit Infotech Limited to M/S Knowledge Root Education Pvt Ltd. and Mr. Sudhakiran Reddy Sunkerneni.
  - 1.2.It is observed that the warrants were allotted to Mr. Sudhakiran Reddy Sunkerneni on November 16, 2022 whereas the consideration amount for the said warrants was received by the company on November 18, 2022 i.e. with a delay of two days. Thus, the company has failed to comply with Regulation 169(2) of the ICDR Regulations.
- 2. The aforesaid non-compliance is viewed seriously. You are hereby warned and advised to ensure compliance with all applicable provisions of ACDR
